

JSU - Annual Safety Briefing Seminar-No. 30.90.320 1T - OPS-M® - EN

Based on the industrial safety ordinance and provisions by trade associations, this web-based safety training OPS-M® „Online-Präsenz-Seminar-Management“ satisfies demands for an annual safety briefing in the electrical sector. Topics are chosen in view of basics requirements for operating electrical systems and are specified to match the company’s operational needs.

We teach online in front of the already familiar projection screen as well as using a flip chart and we will also include workshops and demonstrate samples. Participants will be able to follow the seminar and complete tasks using their seminar folder sent to them in advance.

The FBZ-E cooperates with Convario GmbH & Co. KG from Oldenburg to provide ideal connection technology. Participants will be contacted prior to the seminar date to check that their relevant equipment works adequately. Convario will support the actual seminar to ensure good transmission quality.

Topics:

- ⚡ Development of accident figures and analysis of accidents at work
- ⚡ Hazards in the electrical scope of application and principles of protection
- ⚡ New standards and provisions regarding operational health and safety including PPE
- ⚡ Risk assessments, appropriate measures and documentation requirements

Procedure:

1. The FBZ-E requires the participants’ names, postal addresses, telephone numbers and E-Mail addresses two weeks ahead of the seminar.
2. Once all contact data is received, seminar materials will be sent out to participants.
3. One week before the seminar, Convario will contact each participant to clarify technical requirements and will put the seminar date online for that participant.
4. The seminar will take place during that agreed time.
5. As in regular seminars, with participants being physically present, questions can be asked any time during this online-seminar.
6. Certificates and stickers for safety-logbooks will be sent to participants after the seminar. The company booking that seminar will receive copies of certificates.
7. This seminar will be part of our periodic reminder for qualification’s updating seminars.
